Your proxy(ies) will also be entitled to vote at his/her discretion on any resolution properly put to the Meeting other than those referred to in the Notice.
- In the case of joint holders of Shares, the vote of the senior holder who renders a vote, whether in person or by proxy, shall be accepted to the exclusion of the vote(s) of other joint holder(s) and for this purpose seniority shall be determined by the order in which the names stand in the register of members of the Company. Several executors and administrators of a deceased member in whose name any share stands shall for such purpose be deemed joint holders thereof.
- The proxy form must be signed by you or your attorney duly authorised in writing. In the case of a corporation, this form must be executed under seal or under the hand of an officer or attorney duly authorised.
- To be valid, this proxy form together with the valid power of attorney (if any) or other authority (if any) under which it is signed or a notarially certified copy thereof must be deposited at the head office and principal place of business of the Company or the address of the Company’s branch share registrar and transfer office in Hong Kong, Tricor Secretaries Limited as soon as possible and in any event not later than 48 hours before the time appointed for holding the Meeting or any adjournment thereof.
- A proxy need not be a member of the Company, but must attend the Meeting in person to represent you. A proxy shall be entitled to exercise the same powers on behalf of a member who is an individual and for whom he/she acts as proxy as such member could exercise. In addition, a proxy shall be entitled to exercise the same powers on behalf of a member which is a corporation and for which he/she acts as proxy as such member could exercise if it were an individual member.
- Completion and delivery of this proxy form will not preclude you from attending and voting at the Meeting if you so wish, but your proxy’s authority to vote on a resolution is to be regarded as revoked if you attend in person at the Meeting and vote on that particular resolution.
- The Company reserves its right to treat any proxy form which has been incorrectly completed in some manner as valid if such incorrectness is considered by the Company, at its absolute discretion, not material.
- The Company reserves its right to request (i) any member or his/her/its proxy to produce proof of identity when attending the Meeting; and (ii) any representative of a corporate member to produce proof of identity and a copy of the resolution of the board of directors or other governing body or power of attorney of that member appointing such representative to attend the Meeting.
- Pursuant to Rule 13.39(4) of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited, the resolution set out in the Notice will be decided by poll at the meeting.
- In view of the recent development of COVID-19 pandemic, and in order to better protect the safety and health of the shareholders of the Company (the “Shareholders”), the Company will not serve refreshments at the Meeting to avoid the coming into close contact amongst participants at the Meeting. The Company wishes to remind its Shareholders and other participants who will attend the Meeting in person to take personal precautions and abide by the requirements of pandemic precaution and control at the venue of the Meeting. The Company also advises its Shareholders to attend and vote at the Meeting by way of non-physical presence. The Shareholders may choose to vote by filling in and submitting this proxy form, and appoint the Chairman of the Meeting as a proxy to vote on relevant resolution as instructed herein instead of attending the Meeting in person.

PERSONAL INFORMATION COLLECTION STATEMENT
